A farmer from Indonesia's Central Sulawesi province has accused PT Astra Agro Lestari, which is operating in his village, of land grabbing and for criminalizing him and his family which resulted in the farmer's imprisonment.	Indonesia	Sulawesi Barat	ADM, Bunge, Cargill, Sime Darby	<p>ADM - The detention of the 4 farmers is a criminal case regarding the theft of fruit (FFB) from a plant owned by PT Mamuang that is in the area of its Cultivation Rights (HGU). During the investigation process in October 2017, documents were investigated and a field inspection carried out by the National Land Agency (BPN), including the West Sulawesi Province on an area of 42 hectares claimed by villagers of Polanto Jaya, Central Sulawesi. The results proved that the area that was legally claimed was PT Mamuang's HGU area, which was entirely included in the West Sulawesi region. As differing views arise, the company tries to resolve them through deliberation to create consensus. However, if consensus is not met, the company submits it a legal decision.</p> <p>Bunge - Directly engaged with Astra. Astra is open to seeking resolution via mediation</p> <p>Cargill - We have reached out to Astra Agro Lestari on the allegations and have been informed that the detention of 4 farmers is purely on the basis of criminality, namely theft of fruit (FFB) from a plantation owned by PT Mamuang - an area in its Cultivation Rights (HGU). In October 2017, a field inspection was carried out as part of the investigation process by the National Land Agency (BPN) of West Sulawesi Province. Results from this investigation revealed that an area of 42 hectares claimed by villagers of Polanto Jaya, Central Sulawesi legally belongs to PT Mamuang.</p> <p>Astra Agro Lestari also indicated that, their operations are managed in accordance with applicable laws and social regulations including operations at PT Mamuang. Where grievances related to land disputes are raised, the company engages parties involved by way of deliberation to reach a consensus. However, if the company fails to reach a mutual resolution, a complaint is filed for a legal resolution. In the case of resident named Hemi and PT Mamuang, the Pasangkayu District Court ruled in favor of Astra Agro Lestari with a decision that Hemi is guilty of stealing oil palm fruit in plantations located in PT Mamuang's HGU area with evidence of HGU documents issued by the BPN in 1997. The decision was also strengthened by the Makassar High Court. Hemi submitted an appeal and is now awaiting the Supreme Court's decision on the petition.</p> <p>Regarding residents named Agus Rambagu, Astra Agro Lestari mentioned they met with them on 11 and 12 May 2019 and an agreement had been reached that the land claimed by Agus Rambagu and several people remained part of PT Mamuang's HGU. We will monitor the case and request for Astra to treat the case as a grievance to be updated on its public grievance log.</p> <p>Sime Darby - AAL has resolved to further strengthen the company's implementation of NDPE policy and specifically on its commitment towards Respecting Human Rights outlining certain action items found here: <a href="https://www.astra-agro.co.id/wp-content/uploads/2020/01/AAL-Sustainability-Action-Plan-1.pdf">https://www.astra-agro.co.id/wp-content/uploads/2020/01/AAL-Sustainability-Action-Plan-1.pdf</a></p> <p>Wilmar - PT Mamuang is operating legally and comply with all the regulatory framework. The company had already explored several options with the local communities in resolving the land conflict but to no avail, where the local communities member continued to occupy the land illegally and steal the FFB, as they claimed they are the rightful owner of the land. The FFB theft case has already been duly investigated by the local authority and the suspects have been identified for committing a criminal offence. Multiple	Multiple	AAK, ADM, Bunge, Cargill, IOI, Sime Darby, Wilmar	<p>AAK - On the 13 January 2020 the RSPO issued a letter to FGV Holdings informing them that following the conditional lifting of the suspension of the P&amp;C certificate for Kilang Sawit Serting on the 5 August 2019, under instruction of the RSPO Complaints Panel (CP), Certification Bodies (CB) conducted audits on 6 different FGV units to assess the implementation of the action plan. The RSPO CP reviewed the audit reports and found the results to be unsatisfactory.</p> <p>The findings have led the RSPO CP to re-suspend the P&amp;C certificate of Kilang Sawit Serting and its supply base as well as the certification process for FGV's unsatisfied units.</p> <p>AAK continues to support the RSPO CP process and shares the concerns with the re-suspension of the FGV Holding P&amp;C certificate. AAK also recognises the efforts made by FGV Holdings to develop and implement its action plan taking note of the challenges faced by the scale of implementation, as well as recognising efforts of AAK's tier 1 suppliers supported by FGV Holdings (AAK does not source directly from FGV Holdings).</p> <p>AAK believes that engagement with a supplier facing labour and social issues within its supply base can sometimes be more effective than exclusion. AAK is working with the tier 1 supplier most impacted to implement a controlled purchasing process with FGV Holdings avoiding any FGV Holdings non-RSPO certified mills. This action encourages FGV Holdings to further progress in the implementation of its action plan, whilst sending a clear message that any unsatisfactory compliance in FGV facilities will result in the suspension of purchasing from those units.</p> <p>We consider that the above actions are proportionate and provide ongoing incentives for FGV, one of the major palm oil growers in Malaysia, to meet RSPO compliance requirements, as well as reducing exposure to non-compliant mills of FGV to a minimum.</p> <p>ADM - In January 2020, RSPO suspended Principles and Criteria (P&amp;C) certification processes for all uncertified units of FGV and reimposed its suspension on FGV Holding's Kilang Sawit Serting for non-compliance of the Complaints Panel Decision in November 2018.</p> <p>In January 2020, FGV issued a statement to clarify their position. FGV intends to appeal to the RSPO's latest decision and we will be closely following this matter. Our direct suppliers are in communication with Felda and meetings were held. An action plan is under discussion, but has not been shared with ADM to date.</p> <p>Bunge - Jan-20: Bunge is not directly connected to FGV. The developments of FGV and RSPO are closely monitored over the past months. Bunge takes note of the letter of the RSPO complaints panel including the requested milestones and timeline for FGV. Following Bunge's engagement over the past months, we do recognize FGV's progress on some of the milestones set by the CP. FGV published a statement on their website. Bunge is seeking clarification from trade partners on their position regarding FGV, while at the same time FGV is requested to share further details directly with the Bunge team in SEA. Bunge continues to monitor the developments and progress closely and will share any further updates via our Grievance list.</p> <p>Cargill - Cargill does not buy directly from FGV, however the Company is indirectly linked to our Malaysian refinery supply chain. While Cargill significantly weighs decisions made by RSPO in our grievance process, it is not the only factor in determining how we proceed. Repeated suspension suggests gross non-compliance has been found and is not taken lightly.</p> <p>Cargill has been investigating RSPO's decision basis published audit reports and close communication with FGV. Cargill has decided that for the time being we will not suspend FGV from our supply chain based on the information collected from this investigation. Cargill and its Malaysian suppliers share the opinion that FGV is making progress and that greater transparency on RSPO's Complaints Panel decision is needed. It is understood that the audit was conducted before the deadline set by the CP to implement the directives (31 January 2020). Accordingly, we have taken into account in our decision the previously planned activities undertaken since November 2019 up until 31 January 2020. These activities have been disclosed by FGV in its statement. Additionally, the audit report shared by FGV in its statement shows that though FGV may not have fulfilled all of the directives perfectly, FGV has made significant progress in fulfilling the CP's directives, with a positive recommendation given by the auditors for FGV's operations in Peninsula Malaysia. For the audit on FGV's operations in Sabah, gaps such as lack of complete documentation of migrant workers were identified. However, labor issues in Sabah have to be treated separately due to the external factors involving immigration regulations and processes in Sabah that may impact the sector as a whole, a fact acknowledged by the CP in their decision letter to FGV. FGV has also met the Complaints Panel directive to submit a mechanism to regularize undocumented workers which have registered with the company to be formalised.</p> <p>We also note that FGV is submitting an appeal to the RSPO Complaints Panel this week, and will be sharing an update to stakeholders next week. FGV has also completed the development of a comprehensive 5-year action plan with the Fair Labor Association that was consulted with international and local human rights organizations such as the Human Rights Commission of Malaysia (SUHAKAM) and Tenaganita.</p> <p>We will continue to engage with RSPO and FGV to resolve the situation and follow up on FGV's planned appeal to the CP. We will also continue to monitor FGV's sustainability practices to ensure that they are making progress in ensuring sustainable production of palm oil. We believe that engagement, where a supplier demonstrates will to change is the most productive means for driving transformation in our supply chains.</p> <p>As a member of RSPO, we value the contributions by the CP. Cargill believes mutual transparency is a critical principle to resolve grievances in line with RSPO's principles. Cargill is committed to supporting such efforts that ensure sustainable production of palm oil becomes the norm.</p> <p>Wilmar - On 16 August 2019, U.S. based NGOs International Labor Rights Forum (ILRF), Rainforest Action Network (RAN) and SamOfUs filed a second petition to the United States Customs and Border Protection (CBP). FGV has issued another detail public statement to respond to the petition accordingly. Wilmar convened a meeting with FGV on 26 August 2019 to discuss FGV's progress in addressing the issues raised. We understand from FGV that, a US counsel has been appointed to engage directly with CBP. They have also submitted all the supporting documents to CBP. They have also submitted all the supporting documents to CBP on 9 August 2019 in regards to the first petition. Following the filing of the second petition, the said counsel has submitted similar documents to CBP. FGV has also presented all the action plans and progress to the US Embassy in Malaysia, as well as Malaysian Embassy in US.</p> <p>On 17 September 2019, FGV's Group CEO has provided further updates on FGV's Commitments to Respect Human Rights and Implement Good Labour Practices, where FGV with the support of Procter &amp; Gamble Company (P&amp;G), is finalising the establishment of a multidisciplinary group of non-governmental organisations (NGOs) and non-profits, who will work at various levels to accelerate FGV's human rights remediation efforts.</p> <p>On 21 November 2019, FGV announced that they have been accepted as a Participating Company of the Fair Labor Association (FLA). Under this affiliation programme, FGV is also expected to align its internal standards with the FLA Workplace Code of Conduct as well as to develop a comprehensive social compliance and remediation programme based on the Code of Conduct and the Principles of Fair Labor and Responsible Sourcing or Production for Agricultural Supply Chains.</p> <p>On 13 January 2020, RSPO has suspended the Principles and Criteria (P&amp;C) certification processes for all uncertified units of Felda Global Ventures Holdings' (FGV Holdings) and reimposed its suspension on FGV Holding's Kilang Sawit Serting for non-compliance of the Complaints Panel Decision dated 26 November 2018.</p> <p>On 15 January 2020, FGV issued a statement to clarify their position. On 24 January 2020, FGV issued second statement where they have transparently uploaded all the audit reports and provided their clarifications to the findings. FGV intend to appeal to the RSPO's latest decision and we are following up closely on this matter. The complaint, lodged by Forest Peoples Programme and Ek Hills Research, cites recent bribery convictions of multiple GAR officials in Central Kalimantan as evidence that the company was both aware of these land-use violations and corruptly tried to cover its tracks. They stated that they believe they are operating legally and in accordance with Indonesian law and the requirements of the RSPO.  ADM - Although the complaint that has been filed is new, the allegations date back to 2018, which is why GAR has issued public responses in the past. GAR intends to contest the complaint made through the RSPO Complaint Process, and will also be responding publicly on the article that has been recently published by the Wall Street Journal. We will be closely monitoring GAR's responses and actions on this matter.  Bunge - Bunge listed GAR on our grievance list in 2019 and closed the case in July 2019. The details can be found on page 53 of the public grievance tracker. GAR is an important palm oil supplier into NA, also to BLC NA. The BLC sourcing and sustainability teams are in frequent contact with their colleagues from GAR on related topics such as TTP, the NDPE implementation reporting framework, supply chain related topics, sector transformation etc.. We are confident that GAR is addressing these allegations in the best possible way. On top of that BLC has processes in place to independently monitor and verify allegations and land use change.  Cargill - Cargill sources both directly and indirectly from GAR. Regarding engagement with GAR: 1. GAR has revamped socialization of its Code of Conduct through mandatory e-learning and testing in its operations, including PT Binawati Abadi Pratama. 2. All executives have also signed an acknowledgement form to behave ethically and comply with all laws and regulations. 3. GAR has also released a public statement detailing that: • GAR's operations are legal according to Indonesian laws and RSPO requirements • The requirement to have HGU permits before planting is not applicable to GAR as it only applies to new plantings from 2019 • The company did not sanction the bribery • GAR has taken measures to reinforce anti-corruption in the company through its socialization programs GAR indicated they will dispute the allegations made by FPP by filing an appeal to the RSPO. We are engaging GAR to get further details on the above allegations. We are investigating this grievance in accordance with our grievance procedure and will also take guidance from RSPO's complaints system.  Corbion - Has reached out to its own direct suppliers regarding the complaint issue.  Sime Darby - GAR does not enter Kellogg's supply chain through Sime Darby though SD is actively engaged with GAR regarding pending issues.  Wilmar - GAR is a supplier to Wilmar. Since the case was brought to our attention in 2018, GAR has issued several responses in its Annual Report, on its website and in this report, to transparently communicate the background, and the resolution of the case.
